Aaron Schneider suggested that we add an item d. under JOB FUNCTIONS AND RESPONSIBILITIES, 1. SUPERVISION that states "Attend all home games, all football games and at least 50% of the away games. If they are unavailable they are responsible for scheduling a designee. They are also open to having any school employee apply for the position and removing the qualification that the Athletic Director can't coach.
