- B. Bus Purchase Bids—Carmen Martin, Transportation Supervisor spoke about the bus bids. Three different companies put in bids. Brattain has the lowest bid with International Busses, Bluebird through Western Bus and Thomas/ Freightliners through Schetky. Brattain is local to Albany. We have three types of busses in our lot right now. Carmen Martin prefers the Bluebird busses. She feels like they are the most reliable.
 - i. Martin has concerns with the International Busses. She does not feel like they are as reliable as the Western busses.
 - ii. She recommends that we go with the Western Bus Bluebirds: at \$101,893 \$103,000 to order them. Our plan is to order three busses and will trade in or sell three other busses.
