- 7. Director of Student Services Report Rozeanne Steckler
 - A. Rozeanne is very happy with the on line alternative education program that we are running this year. Kids are making up credits, which hasn't been the case in the past. We are at about 90% success.
 - B. What is currently going on: new semester with schedule changes, MAP testing at elementary level, audit of senior's transcripts, career learning activity schedule for juniors and seniors.

A committee consisting of the core subject teachers in the high school: Andrew Jensen [Social Studies], Chris McKibben [Math], Jordan Terriere [English], and Skip Lynch [Science] met with Rozeanne Steckler to discuss the requirements for an Alsea Honors Diploma.
