Reader board has been up and running since last Thursday. Thanked, Tiffany, and Jackie for setting up and maintaining the board. We will lose \$800.00 a child unless we have a CTE program. We will be implementing this program but will need to get new equipment to implement, i.e., Auto cad, Welders Saws, etc. We will be getting a plasma cutter that will cut ½ inch steel, which students will use to start a business making parts and selling for cost plus small fee. Our plans are to have multiple avenues for our children to learn, college bound, non-college bound and technical students. We are implementing the talented and gifted program. The school is facing a minimum of 10% cut for next year at this point due to measure 97 not passing. Will wait and see if things change in the next few months.


