1. Call to Order, Flag Salute at 1904

2. Approval of Agenda

Jeff Davis motioned to approve the agenda with noted amendments. Deb Lindberg seconded. All in favor. Motion passed unanimously.

- 7. Athletic Report Nicole Davis
 - A. New hires: None

 - C. Openings: HS Boys Basketball Coaches [if we have a team] there are 8 boys signed up to participate, however doing a grade check on all of them this week and they're all on probation. Nicole Davis is meeting with the boys tomorrow to let them know what the expectations are for participation and whether we should do a varsity or JV

season. Nicole requested information from the board on their opinion for High School Boys Basketball. The board agreed that weekly grade checks were a good idea and members commented that we need the boys to eligible to start a team.

D. Fall Sports Update:

- i. HS: Our girls are solidly 2nd in League right now with a record of 13-2 with an overall OSAA ranking on 12th for all the 1A schools. They play their last home game against Eddyville this Saturday at home and then will have their first League championship match on Saturday the 20th at Harrisburg HS.
- ii. MS VB: The girls have a 6-2 record right now for their league and are playing tonight against Crow. They have quite a lot of skill to help the HS program moving forward. They have their MS League Championship on the 26th at McKenzie and the brackets are coming out soon.
- iii. MS FB: The boys and girls are undefeated this season and it has been a pleasure to watch them play 6-man football. They are also playing Crow tonight at home. We have a good solid program starting so it won't be too long before our HS program will take off again.
- iv. HS Football: Noah Estes is having a wonderful football season with Philomath. The new coach/AD has made a great impression so far. They have a league record of 0-3, but an overall record of 2-4. They play Sisters this Thursday in Sisters.

- F. Roof Repairs We still need to replace the roof. We are still working with the insurance company to make sure that we get the amount needed to replace the roof from the insurance company. We are looking at around \$65,000 for the roof repair. We should get around \$56,000 total to cover the costs. We are working the roofing company to make this as affordable as possible.
