- 1. Call to Order, Flag Salute at 1900
- Approval of Agenda Linda Montanez motioned to approve the agenda as presented. Deb Lindberg seconded. All in favor. Motion passed unanimously.

 Deb Lindberg motioned to approve the minutes as with the change to the correct date at the top and bottom. Jeff Davis seconded. All in favor. Motion passed unanimously.

- 5. Information Items -
 - A. Oregon House Bill 3063 Terry Lunsford. Terry Lunsford talked about her opposition to Oregon House Bill 3063. Terry Lunsford is asking board members advocate for standing against this bill. Marc Thielman explained that many people do not remember how horrible some of the diseases are that we have vaccinations for now, and therefor opt out of vaccinations. He pointed out that this bill is less about vaccinations and more about the state forcing people to do things with their children that parents are uncomfortable with.

D. Spring Sports Update:

- i. HS Track: We have some phenomenal athletes out this year on both the boys' and girls' side. We've got boys throwing the Discus 107'9: Noah Estes, the Javelin 120'7 and 117'9: Noah Estes and Dillon Elbers, and running the 100m in 13.49 and 13.53: Dillon Elbers and Dom Schneider. We have girls throwing the Javelin 81'8 and 41'4: Jessica Carlisle and Tuana Ehervicchi, running the 100m in 13.49 and 13.84: Jessica Carlisle and Emma, and we even have an athlete that is ranked 14th in the state (all schools 1A-6A) and ranked 1st for all 1A schools in Triple Jump: Jessica. They compete in our new Special District track meet this Friday and Saturday up at Portland Christian HS.
- ii. MS Track: Our Middle School just finished up their District meet this last weekend and did extremely well given the issues that they had (being disqualified w/o proof, having SPED athletes disqualified/scratched, etc.). While I write this, I haven't had the opportunity to talk face to face yet with the McKenzie AD to try and rectify these mistakes. However, with all the issues we have had this previous weekend, we are taking quite a few athletes to the Meet of Champions on Thursday the 23rd. Owen, RJ, McKenzie, Hayden, Aubrey, and Salix (this is all dependent on the athletes being accepted via the Meet Hosts)

E. Other News:

i. At the AD Conference this past month I was awarded the OADA Leadership Award. We also went through a ton of our SOP's which we planed to finish up today. I also have our schedules for this next year and have filled all, if not most, of our open play dates for all sports. I will also be doing a Title IX audit once school is out to get a list going of things we can start to improve on for the upcoming years. It was suggested that if we have a list of the things, we know we need to work on, that if we are sued, it will go a long way toward keeping us out of too much trouble. I would also like the board to seriously consider allowing me to start the hiring process of a new Football Coach. I need to be able to let whoever I hire know before the summer, so we can communicate to the athletes what this summer will look like for their program (I can get them into a summer passing league and conditioning).
